The are many ways in which a school manages the NSW Education Standards Authority (NESA) and Parramatta Diocesan Compliance requirements. One of the ways is to publish information in the College information letters as well as the Website.

Some of the compliance items which I would like to highlight in this information letter are:

Register of enrolments- When a student under 17 years of age leaves school with an unknown destination the school has a responsibility to inform the local Department of Education School Education Area of the name and last known contact details for the student concerned.

Complaints, grievances and communication - Schools are required to have a complaints and grievances policy. This policy can be found on the website under "About Us / School Policies and Procedures".

Pastoral Care Policy -Integral to the Pastoral Care Policy are the Restorative Justice program, Anti-Bullying policy, Student Rights and Responsibilities as well as Student Discipline. These policies and programs are available both in the Student Planner and on the School Website under "About Us/ Policies and Procedures".

Supervision - Schools are responsible for offering a safe and supportive environment for the students in their care. One key aspect of this is supervision.

- Morning supervision commences at 7.40am
- Afternoon supervision concludes at 2.50pm or when the last bus departs the campus.

Corporal Punishment - Any form of corporal punishment is explicitly and without reservation banned as part of any student management at the college.

Procedural Fairness - St John Paul II Catholic College is committed to ensuring procedural fairness in all situations. Procedural fairness refers to what are sometimes described as the 'hearing rule' and the 'right to an unbiased decision'.

The 'hearing rule' includes the right of the person against whom an allegation has been made to:

- know the allegations related to a specific matter and any other information which
- will be taken into account in considering the matter
- know the process by which the matter will be considered
- respond to the allegations
- know how to seek a review of the decision made in response to the allegations.

The 'right to an unbiased decision' includes the right to:

- impartiality in an investigation and decision-making
- an absence of bias by a decision-maker. Procedural fairness includes making available to students and parents or caregivers the policies and procedures under which disciplinary action is taken. At St John Paul II Catholic College, these policies are contained in the Student Planner, Information Handbooks issued to students and their parents/caregivers and on the college website.

Finally, I am always happy to speak to you about your child's education or issues that affect their education. If I cannot help you directly, I will ensure you are put in contact with the person/s that can assist you. If I am not available when you call, it is only because someone else 'got in' before you, but I will always endeavor to get back to you if someone else cannot assist you. I look forward to knowing that our faith in God will strengthen all of us as we work to ensure the very best Catholic Education possible for those in our care.
